

BOARD OF TRUSTEES OF THE MIDDLESEX COUNTY COLLEGE

Minutes of the Meeting of June 25, 2008

A regular meeting of the Board of Trustees of Middlesex County College was held at 9:03 a.m. in the Chambers Hall Boardroom on the College campus. Members present were: Mmes. Palumbo and Power and Messrs. Antisell, Bauer, Finkelstein, Mulkerin, Raja, Rivas, Sica and Tighe. Ms. Wesnowsky and Dr. Piegari were absent. Also in attendance were Dr. La Perla-Morales, Mr. Hoffman, Ms. D'Aloisio and several staff members.
