WHEREAS, N.J.S.A. 18A:64A-25.6 permits the award of an agreement by a County College without public advertising for bid and bidding therefore notwithstanding that the cost or contract price will exceed the bid threshold, when an emergency affecting the health, safety or welfare of occupants of College property requires the immediate delivery of materials or supplies or the performance of the work provided that the agreement is awarded in accordance with the terms of N.J.S.A. 18A:64A-25.6; and

WHEREAS, on October 28-29, 2012, the health, welfare and safety of the College community was affected by Superstorm Sandy which caused widespread damage to trees on campus; and

WHEREAS, emergency action had been taken because there was insufficient time to solicit formal bids; and

WHEREAS, a written requisition for the performance of certain work had been filed by Donald R. Drost, Jr., Executive Director of Facilities Management of the College in accordance with N.J.S.A. 18A:64A-25.6, a copy of which is attached hereto as an exhibit; and

WHEREAS, David Fricke, Director of Purchasing and Inventory, concurred that an emergency existed and being so satisfied

authorized the award of a contract to Sunshine Tree and Landscape LLC of Stewartville, New Jersey; and

WHEREAS, Sunshine Tree and Landscape LLC was awarded a local supplier contract for emergency tree services through Special Quote # 9760. Sunshine Tree and Landscape LLC possessed the expertise and equipment as well as being available to immediately remove and prune damaged trees.

NOW, THEREFORE, BE IT RESOLVED that the Board of Trustees hereby approves the award of a contract pursuant to N.J.S.A. 18A:64A-25.6 to Sunshine Tree and Landscape LLC to provide the materials and services for emergency tree services in the not-to-exceed amount of \$43,200.00.

6. WHEREAS, On October 27, 2010, the Middlesex County College (the “College”) issued a request for proposals (“RFP”) from qualified firms for the development, design, installation and operation of solar photovoltaic systems at various locations at the College;

WHEREAS, On December 22, 2010, the College received responses to the RFP from various vendors and on January 26, 2011, the College awarded a contract to BP Solar International, Inc. (“BP Solar”);

WHEREAS, On February 14, 2011, BP Solar refused to enter into the contract with the College;

WHEREAS, the College has advised BP Solar that, due to its failure to enter into the contract, it would require BP Solar to forfeit its \$20,000 bid bond;

WHEREAS, BP Solar asserted the position that it should not be required to relinquish the bid bond, and it would only do so in exchange for a release of the College’s claims against BP Solar.

NOW, THEREFORE, BE IT RESOLVED as follows:

1. The College has determined that it should require BP Solar to relinquish its bid bond.
2. The Board authorizes Dr. Joann La Perla-Morales, President, to execute a Release of claims against BP Solar.
3. The Release releases BP Solar from all claims that could be asserted by the College relating to the award of the RFP.
4. A form of the Release is attached hereto.

After discussion, the motion was approved.

FINANCE COMMITTEE

Mr. Finkelstein moved, seconded by Mr. Antisell, for adoption of resolutions 1 through 5:

1. WHEREAS, The Board of Trustees has determined that \$78,774,662 is the amount necessary for the Current Unrestricted Fund and \$2,000,000 is the amount necessary for the Minor Capital Fund for said fiscal year July 1, 2013 to June 30, 2014; and  
  
WHEREAS, The Board of Trustees held a public hearing to review said budget on February 22, 2013,  
  
NOW, THEREFORE, BE IT RESOLVED As follows:
  - a. The budget for the fiscal year July 1, 2013 to June 30, 2014 in the amount of \$78,774,662 for Current Unrestricted Operations and \$2,000,000 for Minor Capital be approved; and
  - b. The Assistant Secretary of the Board of Trustees be, and she is hereby, instructed to forward a copy of said budget to each of the members of the Board of School Estimate; and
  - c. A public hearing by the Board of School Estimate with respect to the amount of money estimated to be necessary for Current Unrestricted Fund and Minor Capital Fund for the fiscal year July 1, 2013 to June 30, 2014 shall be held at the Freeholders Meeting Room, County Administration Building, New Brunswick, New Jersey at a date and time to be determined; and
  - d. The Vice President for Finance and Administration be, and she is hereby, instructed to publish in the Home News Tribune, East Brunswick, NJ, at least seven (7) days prior to the date fixed for the public hearing and also set forth an itemized statement as to the amount of money which the Board of Trustees has determined to be necessary for the Current Unrestricted Fund for the Fiscal Year July 1, 2013 to June 30, 2014, which notice shall also indicate that said itemized statement will be on file and open to examination by the public between 8:30 a.m. and 4:30 p.m., Monday through Friday, at the Office of the Vice President for Finance and Administration at Middlesex County College, Edison, NJ, from the date of publication to the date of the public hearing.
2. WHEREAS, The President has recommended an increase in the tuition rates, for academic sessions scheduled for FY 2014,

including Summer I session FY 2013, in order to provide a portion of the revenue resource for the services to be rendered; and

WHEREAS, The President has developed a Current Unrestricted Fund to provide educational and other services to the students of Middlesex County College for the year July 1, 2013 to June 30, 2014; and

WHEREAS, Said services are funded by students, the State of New Jersey and the County of Middlesex; and

WHEREAS, As required by the Higher Education Restructuring Act of 1994 a public hearing was held on February 22, 2013,

NOW, THEREFORE, BE IT RESOLVED That the following changes in credit hour tuition rates, be approved commencing with the sessions scheduled for FY 2014, including pre-summer session FY 2013 as follows:

- a. In-county tuition credit hour rate be increased from \$102.00 per credit hour to \$103.00 per credit hour; and
  - b. Out-of-county tuition credit hour rate be increased from \$204.00 per credit hour to \$206.00 per credit hour; and
  - c. Out-of-state tuition credit hour rate be increased from \$204.00 per credit hour to \$206.00 per credit hour.
3. BE IT RESOLVED, That the invoice for professional services rendered by the firm of Wilentz, Goldman & Spitzer for the period October 1, 2012 through and including December 31, 2012 be approved for payment in the amount of \$11,759.32.

4. WHEREAS, The College has previously determined that it desired to engage in a master planning process and also to develop a Long Range Facilities Plan and a Long Range Capital Plan; and

WHEREAS, The College engaged L.R. Kimball for that purpose; and

WHEREAS, A report entitled *Master Plan for Middlesex County College* dated August 2012 has been produced, reviewed and approved by the Board; and

WHEREAS, The Board will utilize the report for planning and as a Long Range Facilities Plan and a Long Range Capital Plan;

NOW, THEREFORE, BE IT RESOLVED, That the Board of Trustees of Middlesex County College adopts the *Master Plan for Middlesex County College* dated August 2012; and

BE IT FURTHER RESOLVED that the Board adopts sections 2, 4, and 5 of the *Master Plan for Middlesex County College* dated August 2012 as its Long Range Facilities Plan.

5. RESOLUTION APPROVING AND AUTHORIZING THE UNDERTAKING AND IMPLEMENTATION OF A PROJECT CONSISTING OF THE PLANNING, CONSTRUCTING AND EQUIPPING OF AN ACADEMIC SCIENCE BUILDING ON THE EDISON, NEW JERSEY CAMPUS AND AUTHORIZING THE FINANCING OF ALL OR A PORTION OF THE PROJECT THROUGH PROGRAM(S) MADE AVAILABLE BY THE STATE OF NEW JERSEY FOR NEW JERSEY INSTITUTIONS OF HIGHER EDUCATION AND OTHER AVAILABLE FUNDING SOURCES; APPROVING AND AUTHORIZING THE FORM OF THE APPLICATION TO THE SECRETARY OF HIGHER EDUCATION FOR PARTICIPATION IN SUCH PROGRAM[(S)] AS ARE APPLICABLE TO THE PROJECTS WITH SUCH CHANGES AS ARE APPROVED BY THE OFFICERS OF THE INSTITUTION DESIGNATED HEREIN AND THE SUBMISSION OF THE APPLICATION TO THE SECRETARY OF HIGHER EDUCATION; APPROVING AND AUTHORIZING THE EXECUTION AND DELIVERY OF ANY AND ALL AGREEMENTS IN CONNECTION WITH UNDERTAKING, IMPLEMENTING AND FINANCING THE PROJECTS IN THE FORM(S) APPROVED BY THE OFFICERS OF THE INSTITUTION EXECUTING SUCH AGREEMENT(S); AND DESIGNATING AND AUTHORIZING THE OFFICERS OF THE INSTITUTION TO TAKE THE AFOREMENTIONED ACTIONS AND TO TAKE ANY AND ALL SUCH OTHER ACTIONS DEEMED NECESSARY OR DESIRABLE TO UNDERTAKE, IMPLEMENT AND FINANCE THE PROJECT(S).

WHEREAS, The Board of Trustees (the "Board") of Middlesex County College ("the Institution") desires to approve the undertaking, implementation, and financing of a project (the "Project") consisting of the planning, constructing, and equipping of an academic science building on its Edison, New Jersey campus; and

WHEREAS, The Board desires to approve the aggregate costs of the Project paid and or financed through all sources in an amount not to exceed \$18,210,400; and

WHEREAS, The Board desires to finance all or a portion of the Project through three of the Programs made available by the State of New Jersey (the "State") for certain projects of New Jersey institutions of higher education (the "Programs"); and

WHEREAS, The Programs are the Building Our Future Bond Act, P.L. 2012, c.41 (the "GO Bond Act") for \$13,600,000; the Education Facilities Trust Fund, N.J.S.A. 18A:72A-49 *et seq.* ("HEFT") for \$2,992,000; and the Higher Education Equipment Leasing Fund Act, N.J.S.A.18A: 72A-40 *et seq.* ("ELF") for \$1,618,400; and

WHEREAS, The Board has determined that the Project will assist in serving the needs of its students, the educational priorities of the State of New Jersey, and providing a benefit to the Institution; and

WHEREAS, The Board desires to approve financing of all or portions of the Project through the GO Bond Act, HEFT, and ELF; and

WHEREAS, Portions of the Project may also be financed by bonds issued by the New Jersey Educational Facilities Authority which bear tax-exempt interest for federal income tax purposes ("Tax-Exempt Bonds"), commercial loans or funds otherwise available to the Institution; and

WHEREAS, The Board wishes to approve the form of the Application to be submitted to the Secretary of Higher Education (the "Secretary") for the proposed Programs for the Project, and to designate and authorize officers of the Institution to take necessary and desirable actions to undertake, implement and submit to the Secretary the Application for the Project; and

WHEREAS, The Board hereby approves the Long Range Capital Plan of the Institution in the form attached hereto as Exhibit A and authorizes and directs the officers designated in this resolution to include the Long Range Capital Plan in the Applications approved herein; and

WHEREAS, The Board desires to authorize certain officers of the Institution to determine the Financing Structure which is most economically advantageous to the Institution provided the Financing Structure includes utilization of the Proposed Programs,

and take all action necessary or beneficial to accomplish the financing of the Project including the financing of capitalized interest, if any, and other costs of issuing any debt including, Tax-Exempt Bonds or other financings (“Financing Costs”); and

WHEREAS, The Board reasonably expects to reimburse expenditures for costs of the Project paid prior to issuance of Tax-Exempt Bonds or any debt bearing interest which is exempt from gross income for federal income tax purposes which will fund an applicable Project and/or Program;

NOW, THEREFORE, BE IT RESOLVED, by the Board of Trustees of Middlesex County College as follows:

1. The Board approves the Project and authorizes the undertaking, implementation and financing of the Project in a maximum aggregate amount not to exceed \$18,210,400 [The Board approves the Long Range Capital Plan of the Institution in the form attached hereto as Exhibit A].

2. The Board approves the financing of all or any portion of the Project through the GO Bond Act, HEFT and ELF. The Board approves the Application for funding of the Project through such Programs in the form submitted to the Board and authorizes and directs the herein defined Designated Officers to submit such Application to the Secretary with such changes, modifications and additions as are approved by the Designated Officers and such changes, modifications and additions shall be conclusively evidenced by the submission of the Application to the Secretary. The Board expressly directs and authorizes the Designated Officers to submit the Long Range Capital Plan in the Application for any Program for which it is required. The Board acknowledges and agrees that approval of the Application and receipt of funds pursuant to the Program(s) will obligate the Institution to:

(a) provide funds for the operation and maintenance of the Project, (b) contribute to the cost of the Project; (c) pay all or a portion of debt service on Tax-Exempt Bonds issued by the New Jersey Educational Facilities Authority to fund the Proposed Program(s) as applicable; and (d) fulfill other conditions imposed under the Programs and hereby directs and authorizes the Designated Officers to certify such acknowledgement and agreement as part of the submitted Application. The Designated Officers are hereby authorized and directed to fulfill all conditions of the Proposed Programs including without limitation providing for the operation and maintenance of the Project and using available funds of the Institution to pay for such operation and maintenance and to satisfy conditions of the Proposed Programs to contribute to the cost of Projects and/or debt service on Tax-Exempt Bonds issued to fund the Proposed Programs from available funds of the Institution.

3. The Board further approves the financing of all or any portion of the Project with Tax-Exempt Bonds, commercial loans and other funds available to the Institution and through the Financing Structure determined to be most economically advantageous to the Institution by the President and Vice President of Finance and Administration (the “Designated Officers”). The Designated Officers are expressly authorized and directed to determine such Financing Structure provided that the Financing Structure includes utilization of Programs which are approved by the Secretary for financing the Project.

4. The Board Chairperson, the Board Secretary, the President and Vice President of Finance and Administration and (each an "Authorized Officer") are each hereby authorized and directed to approve, execute and deliver any and all agreements necessary to undertake, implement and finance the Project and any and all other financing documents and instruments in the form approved by the Authorized Officers executing the same in the name of and on behalf of the Board, in as many counterparts as may be necessary, and to affix or impress the official seal of the Institution thereon and to attest the same and such execution and attestation will be conclusive evidence of the approval of the form and content of such agreements and other documents and instruments necessary to undertake, implement and finance the Project and to pay Financing Costs including through the financing thereof. The Authorized Officers are further authorized and directed to do and perform such other acts and to take such other actions as may be necessary or required, or which may be deemed to be appropriate to implement the purposes of this resolution to undertake, implement and finance the Project and Financing Costs and the payment and/or repayment thereof.

5. This Resolution is a declaration of the official intent of the Institution that the Institution reasonably expects and intends to reimburse expenditures for costs of the Project[s] paid prior to issuance of Tax-Exempt Bonds or other tax-exempt debt issued to fund the Projects/Programs ["Applicable Tax-Exempt Debt"] in accordance with Treasury Regulation Section 1.150-2 and that the maximum principal amount of the Tax-Exempt Debt expected to be issued to finance costs of the Project [s] including amounts to be used to reimburse expenditures for such costs paid prior to the issuance of the such Tax-Exempt Debt is \$18,210,400 (including Financing Costs).

6. All resolutions, orders and other actions of the Board of the Institution in conflict with the provisions of this resolution to the extent of such conflict are hereby superseded, repealed or revoked.

7. This Resolution shall take effect immediately;and be it further

RESOLVED: That no further approvals by the Board are necessary to implement this Resolution.
