2. WHEREAS, There exists a need at Middlesex County College for medical services; and

WHEREAS, The Board of Trustees has retained the Rutgers, the State University of New Jersey/Family Medicine at Monument Square at the rate of \$125 per hour for the purpose of rendering medical services on behalf of the Board of Trustees of Middlesex County College,

NOW, THEREFORE, BE IT RESOLVED, By the Board of Trustees of Middlesex County College as follows:

a. The Board of Trustees hereby appoints Rutgers, the State University of New Jersey/Family Medicine at Monument Square to provide medical services for the period extending from November 14, 2017 through November 13, 2018, and Rutgers, the

State University of New Jersey/Family Medicine at Monument Square has agreed to serve and be compensated for the reasonable value of its services.

- b. This contract is awarded without competitive bidding as a "Professional Service" under the provisions of the County College Contracts Law because Rutgers, the State University of New Jersey/Family Medicine at Monument Square is comprised of physicians of the State of New Jersey and the practice of medicine is regulated by the laws of the State of New Jersey.
- 3. WHEREAS, It is deemed appropriate for Middlesex County College to have a Public Agency Compliance Officer designated; and

WHEREAS, The College shall designate such an officer or employee to serve as its Public Agency Compliance Officer pursuant to N.J.A.C. 17:27-3.5; and

WHEREAS, Said Officer shall perform duties as prescribed by the rules and regulations of the United States and the State of New Jersey to assure compliance of College operations,

NOW, THEREFORE, BE IT RESOLVED, That James Kinney, Director, Labor Relations and Compliance, be appointed as Public Agency Compliance Officer for the period November 14, 2017 through November 13, 2018 for Middlesex County College; and

BE IT FURTHER RESOLVED, That a copy of this appointment be forwarded to the State of New Jersey, Office of the Treasury, Division of Contract Compliance & Equal Opportunity Office, pursuant to N.J.A.C. 17:27-3.5.

- 4. That the <u>Home News Tribune</u> of Somerville, New Jersey be designated as the Official newspaper for publication of all legal notices affecting the College or the Board of School Estimate.
- 5. That:
