# **PRESENTATION**

WHEREAS, Judge Daley generously volunteered his professional knowledge and insight to the College, enhancing the quality of educational services provided by the institution to the residents of Middlesex County, and NOW, THEREFORE, BE IT RESOLVED, That the members of the Board of Trustees of Middlesex County College do hereby recognize and acknowledge their sincere appreciation and gratitude to Judge Daley for his outstanding contributions, the interest he has shown, and the assistance he has given to the campus community and residents of Middlesex County; and

2. Based on the recommendation of Middlesex County College Board of Trustee Vice Chair Mark Finkelstein, authorize the approval of President McCormick's expenses for the fourth quarter of FY2020.

After discussion, the motion was approved.

Ms. Buteas reported the marketing team, TopRight has recommended removing "County" from the name of the College and renaming it "Middlesex College" effective January 1, 2021.

Ms. Buteas moved, seconded by Mr. Raja, for approval of resolution #3:

3. WHEREAS, the Board of Trustees of the Middlesex County College at its inception established the corporate name to be the Board of Trustees of Middlesex County College and a name for the College of Middlesex County College; and

WHEREAS, the President established a 13-member marketing group ("Marketing Group") consisting of the President, Administrators and representatives of the College to study and review the name of the Middlesex County College and determine whether the name should be revised; and

WHEREAS, the Marketing Group along with Top Right, a marketing consultant, held 5 workshops and interviewed members of key stakeholder groups, including employees, students, alumni and external stakeholders in the community, including elected officials, K-12 superintendents and business representatives relating to the name and potential change of the name of the College; and

WHEREAS, as a result of the study, the President finds merit in the change of the name and recommends to the Board of Trustees that both the corporate name and the college name should be changed to "Board of Trustees of Middlesex College" and "Middlesex College", respectively; and

WHEREAS, the Board of Trustees is granted the power "to adopt or change the name of the County College" pursuant to N.J.S.A. 18A:64A-12a; and

WHEREAS, the Board of Trustees has determined that it is in the best interest of the College to change the corporate name to "Board of Trustees of Middlesex College" and the College name to "Middlesex College."

NOW, THEREFORE, BE IT RESOLVED by the Board of Trustees of Middlesex County College as follows:

- 1. The corporate name of the College shall be "Board of Trustees of Middlesex County";
- 2. The new name of the College shall be "Middlesex College";
- 3. The name changes shall be effective as of January 1, 2021;
- 4. The President is authorized to take such actions as are appropriate to effectuate the name change.

After discussion, the motion was approved.

## **BYLAWS COMMITTEE**

Bylaws Committee Chair Anderson reported the Committee met last week to discuss two modifications. The first proposed modification clarifies the notice requirements for the Board Executive Committee meetings and ensures compliance with the Open Public Meetings law. The proposed Section 6.5.h. reads:

#### Section 6.5.h. Executive Committee

- 1. The Executive Committee shall consist of four voting members as follows: Chairman, Vice Chairman, Treasurer, and Secretary.
- 2. The Executive Committee shall meet between scheduled meetings of the Board or when there is need for an emergency meeting. The meeting may be called by the Chairman, Vice Chairman, or President.
- 3. Meetings of the Executive Committee at which actions may be taken by the Executive Committee on behalf of the Board should be conducted pursuant to the guidelines for Special Meetings of the Board (Section 7.3).
- 4. The Committee shall take actions on such matters as President and/or Chairman deem necessary in order to maintain the necessary operations of the College before the next scheduled meeting of the Board.
- 5. The Secretary shall send minutes containing the actions taken by the Executive Committee to all members of the Board within twenty days after the Executive Committee meeting.
- 6. The actions taken by the Executive Committee shall be considered for ratification by the full Board at the Board's next scheduled meeting.

The second proposed change is to the existing Section 7.4 – Attendance of Public. The proposed modification sets forth a procedure that people requesting to be heard at the Board meeting must register with the Secretary of the Board 24 hours prior to the meeting, sets a time limitation of three minutes and sets forth the powers of the Board Chairman to control a meeting. The proposed Section 7.4. – Attendance of Public reads:

#### Section 7.4 – Attendance of Public

All regular meetings and special meetings shall be open to attendance by the public. Any organization, group or individual from within or without the College will be recognized to be heard on agenda items provided that requests to be heard shall have been registered with the Secretary at least twenty-four hours before the meeting. Public participation shall be governed by the following rules:

- 1. A participant must be recognized by the Chair or presiding officer and must preface comments by an announcement of his/her name, municipality of residence, and group affiliation, if applicable;
- 2. Each statement made by a participant shall be limited to not more than three minutes;
- 3. No participant may speak more than once on the same topic until all others who wish to speak on that topic have been heard;
- 4. All statements, questions, or inquiries shall be directed to the Chair or presiding officer and any questions or inquiries directed by a participant to another Board member shall be redirected to the Chair or presiding officer who shall determine if such statement, question, or inquiry shall be addressed by the Chair or presiding officer on behalf of the Board or by the individual Board member;
- 5. The Chair or presiding officer may:
  - a. Interrupt, warn, and/or terminate a participant's statement, question, or inquiry when it is too lengthy;
  - b. Interrupt and/or warn a participant when the statement, question, or inquiry is abusive, obscene, or may be defamatory;
  - c. Request any person to leave the meeting when that person does not observe reasonable decorum;
  - d. Call for a recess or an adjournment to another time when the lack of public decorum interferes with the orderly conduct of the meeting; and
  - e. Waive these rules when necessary for the protection of privacy or to maintain an orderly operation of the Board meeting.

The proposed amendments to the Middlesex County College Board of Trustees Bylaws were presented to the Board of Trustees. The amended Bylaws were sponsored by Mr. Anderson and Ms. Buteas. Mr. Anderson moved to introduce the amended Bylaws, seconded by Mr. Oras, and approved by the Board. The amended Bylaws will be voted on at the October 21, 2020 Board of Trustees meeting at 8:30 a.m.
